List of market makers and authorised primary dealers using the exemption under the UK version of Regulation (EU) No 236/2012 of the European Parliament and of the Council of 14 March 2012 on short selling and certain aspects of credit default swaps

According to Article 17(13) of the UK version of Regulation (EU) No 236/2012 of the European Parliament and of the Council of 14 March 2012 on short selling and certain aspects of credit default swaps ("UK SSR"), the FCA shall publish and keep up to date on its website a list of market makers and authorised primary dealers who are using the exemption under the UK SSR.

The FCA will update this list when new market makers or authorised primary dealers notify us of their intention to use of the exemption under Article 17(1) or Article 17(3) of the UK SSR for their trading activities on instruments admitted to trading in the UK and the FCA has not prohibited its use. Article 17(7) allows the FCA to prohibit the use of the exemption within 30 calendar days following the notification if the FCA considers that conditions for the use of the exemption are not met or subsequently if it considers those conditions are no longer satisfied.
